Hamilton discusses courthouse expansion, judiciary changes

About 90 BCBA members attended the Oct. 12 meeting to hear Presiding Circuit Judge **Gene Hamilton's** annual "State of the Court" report.

Judge Hamilton said the current thinking on courthouse expansion is to add two floors to the 1992 courthouse addition. The third floor would include a large courtroom and jury assembly area, while the Prosecutor's Office would take up the fourth floor. He said another large courtroom is needed because 1-West is not large enough for major jury trials.

Most of the second floor space in the original building now occupied by the Prosecutor's Office would be taken over by the Circuit Clerk.

On the first floor of the original building, the Public Administrator would expand into some of the space now used by probate and accounting, and probate and accounting would use the area now designated as the attorney conference room. The conference room would be moved to the second floor.

The Juvenile Office would remain on the ground floor and expand into the area now used for jury assembly.

Other plans include moving the Public Defender to the former Guaranty Land Title Co. building on Ash Street and using the vacated space in the Johnson Building for storage.

Judge Hamilton said the present plan is to schedule a bond issue election next April to fund the \$9.5 million courthouse expansion/renovation plus \$5 million for finishing the third floor of the County Administration Building and remodeling the lower floors.

He said if the bond issue does

not pass, a temporary solution to space needs may be to move the Prosecutor's Office to the third floor of the County Administration Building.

Judge Hamilton noted that statutory changes will convert Division IV to a Circuit Judge position and add a new Associate Circuit Judge who will preside over new Division XI. He added that the Court en Banc has decided to continue Division VIII as a Family Court Commissioner position.

All Boone County judge seats except that of Judge **Gary Oxenhandler** will be up for election in November 2006, Judge Hamilton noted.

He said that the judges' office area will be remodeled out of current available funds to accommodate the additional judge. The quarters will be cramped, but that problem will be alleviated if the courthouse expansion bond issue is passed, ultimately allowing space now used by the Circuit Clerk's criminal division to be taken over by the court reporters.

In other remarks, Judge Hamilton said:

* A committee of judges is studying possible rules to govern cell phone usage in the courthouse. The major concern is that many cell phones can take photographs and make sound recordings. A lesser problem is phones ringing and people talking on cell phones in courtrooms.

* A committee of lawyers will study technology issues at the courthouse, including the possibility of wireless Internet.

* Lawyers who request first settings should plan to use them or face difficulty getting them in the future.

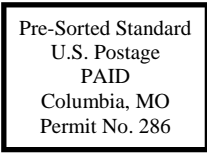
